

## FEE SCHEDULE FOR RELEASE OF PERSONAL INFORMATION

At the Espanola Regional Hospital and Health Centre, we are committed to protecting the privacy and confidentiality of patient health information. Our policies and procedures comply with provincial legislation.

In accordance with Section 54 (10-11) of the Personal Health Information Protection Act (PHIPA). The Espanola Regional Hospital and Health Centre's fee schedule is based on a reasonable cost recovery fee for the access of Personal Health Information. These guidelines are defined in Order HO-009 by the Information Privacy Commissioner of Ontario and set out in a proposed regulation published by the Minister of Health and LTC 2006 (however, not adopted).

Patient health information that is patient or provider identifiable must only be used by authorized personnel on a need-to-know basis. Health information is only accessed or released for:

- **Direct care use**, when requested by a physician or health care facility responsible for direct care of the patient.
- Individual use, when authorized by the patient or legal representative.
- Secondary use, when requested by properly authorized persons or agencies for appropriate uses. Legal use, when required by law.
